## **GENERAL INFORMATION**

The development of Thailand's modern patent system began in the 1870s. Although it started late, as a new industrial country and one of the world's emerging market economies, Thailand's patent development also deserves our attention.




Figure 1 Patent publication trend

In the first ten years, the number of patents in Thailand remained below 2,000 every year. Since 1996, the number of patents in Thailand has increased rapidly. In recent years, the number of patents published in Thailand has been around 14,000 (as shown in **Figure 1**).

Overall, the number of patents in Thailand has maintained a steady growth trend.



## PATENT TRENDS IN THAILAND

Among all patents, invention patents accounted for 61.86%. Meanwhile, the proportion of exterior design in Thailand reached 29.68%, which is in sharp contrast to the countries analyzed in previous reports (as shown in **Figure 2**). This may indicate that the design has received more attention in Thailand.




Figure 3 Legal status

At present, only 12.08% of Thailand's patents are still in force, and most of the other patents are not in force or are pending (as shown in **Figure 3**).

#### PART 2

### **GEOGRAPHIC TERRITORIES**




Figure 4 Top countries of origin

When analyzing the complete historic Thailand patent publications, it is clear that Thailand was the largest country of origin, accounting for 84.36% of the total. The United States was historically the country with the largest number of foreign patent applications in Thailand, accounting for 10.90% of the total, followed by Japan, accounting for 7.12% of the total (as shown in **Figure 4**).




Figure 5 Top countries of origin trend

However, since 2012, the number of patents applied by foreign companies has been increasing every year, while those in Thailand have decreased (as shown in **Figure 5**). It shows that Japan, the United States and Europe pay more and more attention to Thailand's patents.

## **KEY TECHNOLOGIES**

Among the patents in Thailand, the top 10 IPC classification numbers are A61F13/15, C22C38/00, A23L1/00, etc. (as shown in **Figure 6**), indicating that Thailand's patents mainly focus on daily necessities.

### STANDARDIZED CURRENT ASSIGNEES




Figure 7 The top 5 foreign standardized current assignees

In addition to local companies in Thailand, the top five foreign companies in Thailand in terms of patent applications are Honda, P & G, Kao, Unilever and Colgate (as shown in **Figure 7**).

Among all foreign companies, Honda has the largest number of patent applications, reaching 2322. This is mainly because Thailand is the automobile manufacturing center in Southeast Asia and the largest automobile market in ASEAN.
