Introduction

Saudi Arabia is one of the countries with the highest oil reserves, production, and sales volume in the world, known as the "Kingdom of Oil". Driven by the petroleum industry, Saudi Arabia's industrial economy has developed well. This report reveals the development of Saudi Arabia's patent industry (Data as of March 15, 2024).

Part 1: General information




Figure 1 Patent types

The number of patents in Saudi Arabia is not large, and currently there are 48,897 available patents, of which 83.06% are invention patents and 16.94% are design patents (as shown in <u>Figure 1</u>).




Figure 2 Legal status

From the perspective of legal status, in patents that can obtain legal status information, 61.87% are not in force, 23.35% are in force, and 14.79% of patents are still under review (as shown in <u>Figure 2</u>).




Figure 3 Patent application trend in Saudi Arabia

Analyzing the trend of patent applications in Saudi Arabia over the past 20 years, before 2014, the annual number of patent applications in Saudi Arabia was relatively small, while from 2015 to 2022, the annual number of patent applications was much higher than before (as shown in <u>Figure 3</u>). Meanwhile, from 2016 to 2021, the number of patent applications in Saudi Arabia showed a downward trend, but suddenly increased again in 2022. The number of patent applications in 2023 is very small, because some patents have not been publicly disclosed.

Part 2: Geographic Territories




Figure 4 Top regions of origin

In terms of patent technology origin, the proportion of patents applied for domestically in Saudi Arabia is 18.42%, while the remaining 81.58% of patents come from foreign filers. Among foreign filers, the United States have applied for the most patents in Saudi Arabia (as shown in Figure 4).




Figure 5 Patent application trend of top countries

Analyzing the trend of domestic and US filers applying for patents in Saudi Arabia, after 2015, the number of patent applications by filers in both countries has significantly increased compared to the past (as shown in <u>Figure 5</u>). Among them, from 2017 to 2020, the number of patent applications by US filers showed a downward trend, while the number of patent applications by domestic filers showed an increasing trend. In addition, in 2022, the number of patent applications in Saudi Arabia by domestic filers increased significantly compared to 2021.

Part 3: Key Technologies




Figure 6 The top 10 IPC classification numbers

Analyzing the technology fields that have been publicly patented in Saudi Arabia, IPC classification number A61K corresponds to the most patented technologies, indicating that preparations for medical have the highest level of attention (as shown in <u>Figure 6</u>). At the same time, there are also many corresponding patents such as CO7C and CO7D, all of which belong to the field of organic chemistry, and the patents involved may be closely related to the local petroleum industry.

Part 4: Standardized Current Assignees




Figure 7 The top 10 standardized current assignees

In terms of patent filers, Saudi Arabian Oil CO have applied for the most patents, followed by Procter & Gamble (as shown in Figure 7).

Meanwhile, most of the top ten applicants are enterprises engaged in energy and chemical related fields.
